Chapter 1 General Rules
(Purpose)
Article 1 These Academic Rules and Regulations stipulate the necessary matters with regard to the organization and operation of education and research at Toyo University (hereinafter, "the University"), established by Toyo University Incorporated Educational Institution pursuant to the School Education Act (Act No. 26 of 1947) and the Private School Act (Act No. 270 of 1949).

## (Objective of the University)

Article 2 Based on the founding spirit of Dr. Enryo Inoue, the objective of the University is to teach, study, and master the depths of the theories and applications of Eastern and Western academics, while endeavoring to help cultivate and foster an artistic personality and sentiment, thereby developing human resources capable of contributing to the improvement of national and global cultures.
(Self-inspection and Assessment)
Article 3 With the aim of improving the level of its education and research, the University self-inspects and assesses the status of education and research; organization and operation; and facilities and equipment of the University. The University also discloses the results thereof to the public.
2. Details of the above inspection and assessment are specified separately.
(Certified Evaluation and Accreditation)
Article 3-2 In addition to the action of Paragraph 1 above, pursuant to Paragraph 2, Article 109 of the School Education Act, the University undergoes evaluation concerning the overall condition of education, research, etc. of the University by a party certified by the Minister of Education, Culture, Sports, Science and Technology at legally specified intervals, and discloses the results thereof to the public.
(Organizational Training, etc. for Improvement of the Content, etc. of Education)
Article 3-3 The University conducts organizational training and research aimed at improving the content and teaching methods of courses.
2. In addition to the above, for the purpose of sophisticating University operations, the University conducts training to help the faculty and administrative staff members acquire the knowledge and skills necessary for the operation of the University and improve their abilities and qualities.
3. Matters necessary in relation to the above two paragraphs are specified separately.
(Disclosure of Information)
Article 3-4 Pursuant to Article 172-2 of the Ordinance for Enforcement of the School Education Act (Ordinance of the Ministry of Education No. 11 of 1947), the University discloses information on the condition of its education and research activities, etc. by publication, use of the Internet, or any other means that enables broad disclosure of such information.
2. Details of the method of disclosure above are specified separately.

Article 4-2 Each Faculty specifies in its Faculty Regulations the objective of human resources development and other educational and research objectives of the Faculty and its Department(s) or Course(s).
(Policies for Certification of Graduation and Conferral of Degrees, Curriculum Organization and Implementation, and Admission of Students)
Article 4-3 To achieve the objectives provided in the previous Article, each Faculty specifies in its Faculty Regulations the policies concerning certification of graduation and conferral of degrees, organization and implementation of educational curriculums, and admission of students of the Faculty and its Department(s) or Course(s).

Article 5 The admission capacity of each Faculty and Department or Course of the University is as follows

2. The admission capacity of each of the "Indological Studies," "Chinese Language, Philosophy, and Literature," "Buddhist Studies," and "Eastern Art and Culture" Daytime and Evening Courses of the Department of Eastern Philosophy and Culture, Faculty of Letters is specified in the Regulations on Courses of the Department of Eastern Philosophy and Culture, Faculty of Letters, which are formulated separately.
(Correspondence Courses)
Article 6 The Department of Japanese Literature and Culture, Faculty of Letters, and the Department of Law, Faculty of Law, have correspondence courses.
3. Academic Rules and Regulations concerning correspondence courses are established separately.
(Graduate Schools)
Article 7 The University has Graduate Schools.
4. Academic Rules and Regulations concerning Graduate Schools are established separately.
(Attached Facilities, etc.)
Article 8 The University may have libraries, research institutes and centers, and other facilities necessary for education and research as its attached facilities.
5. Regulations concerning attached facilities are established separately.

Section 2 Administrative Organ, and Faculty and Administrative Staff Members
(President)

Article 9 The University has a President.
2. The President governs university affairs and supervises the faculty and administrative staff members belonging to the University.
(Vice Presidents)
Article 9-2 The University may have several Vice Presidents.
2. The Vice Presidents support the President and govern university affairs as ordered by the President.
(Deans)
Article 10 Each Faculty has a Dean.
2. The Dean governs the affairs related to the relevant faculty. (Deans' Council)
Article 11 The Deans' Council is established to respond to the President's request for advice concerning coordination of communications between Faculties and other urgent matters.
2. Regulations for Deans' Council are established separately. (Faculty Council)

Article 12 Each Faculty has a Faculty Council in order to deliberate on matters for which the Faculty expresses its opinions to the President in making decisions, as well as matters related to the operation of the relevant Faculty.
2. Regulations for the Faculty Council are established separately.

Article 13 Deleted
Article 14 Deleted
(Various Committees)
Article 15 When deemed necessary by the President, committees for tasks (hereinafter, "various committees") may be established.
2. Regulations for Various Committees are established separately.

Article 16 Deleted
(Faculty and Administrative Staff Members)
Article 17 The University has full-time professors, associate professors, lecturers, assistant professors, assistants, administrative staff members, staff members with special qualifications, technical staff members, and operational staff members.
2. Besides the above, where necessary, part-time faculty or administrative staff members may be appointed.
(Outside Researchers)
Article 18 The University may have outside researchers.
2. Regulations concerning outside researchers are established separately.

Chapter 3 Completion of Studies, etc.
Section 1 Duration of Studies
(Minimum Duration of Studies)
Article 19 The minimum duration required for completion of the course of undergraduate studies shall be four (4) years.
(Calculation of the Duration of Study)
Article 19-2 When a non-matriculated student (except those without university entrance qualifications) who has earned a specific number of credits at the University enters the University, and when such student is deemed to have taken some of the courses of the University by earning the said credits, the period specified by the University may be included in the calculation of the duration required for completion of the course of undergraduate studies; provided, however, that such period shall not exceed a half of the minimum duration of studies at the University.
2. The above calculation of the duration of studies shall be performed by taking into consideration the number of credits that can be deemed to have been earned after the student's entry into the University, the period spent to earn the said credits, and other matters deemed necessary by the Faculty Council.
(Maximum Duration of Enrollment)
Article 20 The maximum duration of enrollment allowed to earn credits necessary for graduation (hereinafter, "years of enrollment") shall be eight (8) years. The duration of a leave of absence shall not be included in the calculation of the number of years of enrollment.
2. The duration of enrollment of a re-admitted or transferred student shall be the number of years of enrollment described above less the ordinary number of years until re-admission or transfer.

Section 2 Academic Year, Semesters, and Student-free Days
(Academic Year)
Article 21 An academic year starts on April 1 and ends on March 31 of the following year; provided, however, that an academic year for fall semester entrants starts on October 1 and ends on September 30 of the following year.

## (Semesters)

Article 22 An academic year is divided into the following two semesters; provided, however, that the President may change the date of the end of the spring semester and the date of the beginning of the fall semester upon consulting the Faculty Council.
(1) Spring semester: from April 1 to September 30
(2) Fall semester: from October 1 to March 31 of the following year
(Student-free Days)
Article 23 The days on which no classes are offered at the University (hereinafter, "student-free days") are set as follows; provided, however, that the President may change the student-free days or temporarily set student-free days upon consulting the Faculty Council.
(1) Sundays
(2) Holidays stipulated in the Act on National Holidays (Act No. 178 of 1948, July 20, 1948)
(3) Foundation Day (September 16)
(4) The Founder's Day Festival (June 6)
(5) Spring break: from early February to March 31
(6) Summer break: from early August to September 30
(7) Winter break: from late December to early January of the following year Chapter 4 Admission, Withdrawal, Leave of Absence, Dismissal, etc.

Section 1 Admission, Study Abroad, etc.
(Time of Admission)
Article 24 Students shall be enrolled within 30 days from the first day of the semester.
(Eligibility for Admission)
Article 25 Persons eligible to enroll in the first year of the undergraduate program must fall under any of the following items:
(1) Persons who have graduated from a senior high school
(2) Persons who have completed 12 years of regular schooling (including those who have completed equivalent schooling through a program other than a regular program)
(3) Persons who have completed 12 years of schooling in a foreign country or persons designated as having the equivalent by the Minister of Education, Culture, Sports, Science and Technology
(4) Persons who have completed a course of study at an overseas educational institution that is recognized by the Minister of

Education, Culture, Sports, Science and Technology as being equivalent to that of a Japanese senior high school
(5) Persons designated by the Minister of Education, Culture, Sports, Science and Technology
(6) Persons who have passed the University Entrance Qualification Examination (abolished on January 31, 2005)
(7) Persons who have passed the Certification Test for Students Achieving the Proficiency Level of Upper Secondary School Graduates conducted by the Minister of Education, Culture, Sports, Science and Technology under the Ordinance for the Certificate for Students Achieving the Proficiency Level of Upper Secondary School Graduates (Ordinance of the Ministry of Education, Culture, Sports, Science and Technology No. 1 of 2005)
(8) Other persons who are at least 18 years of age who are recognized by the University through individual screening of eligibility for admission as having scholastic ability equivalent to or higher than that of high school graduates.

## (Application and Screening for Admission)

Article 26 Applicants for admission must submit a designated application form, pay the application fee specified in Appendix 1 , and take the screening examination.
(Procedure for Enrollment)
Article 27 Persons who have been admitted to the University must pay the admission fee and submit a written pledge in the designated format.

## (Guarantor)

Article 28 The guarantor must be the applicant's father or mother, or another adult who has an independent source of income.
2. The guarantor shall undertake the responsibility for having the student obeys any University rules and regulations while the student enrolled.
3. Students must promptly submit a notification form when they have changed their guarantor, or their name or place of residence has been changed.
(Student ID Card)
Article 29 A Student ID Card will be provided for persons who have completed the enrollment procedure.
(Mid-course Entry)
Article 30 Persons who fall under any of the following items and apply for mid-course entry to the University may be admitted by the President after taking an examination.
(1) Persons who have graduated from a junior college
(2) Persons who have graduated from a university
(3) Persons who have graduated from a college of technology
(4) Persons who have completed a specialized course of study at a specialized training college (limited to those that satisfy the requirements specified by the Minister of Education, Culture, Sports, Science and Technology)
2. Regulations concerning mid-course entry are established separately.
(Transfers)
Article 31 A student of another university who applies for transfer to the University with permission of the former university may be admitted by the President after taking an examination.
2. Regulations concerning transfers are established separately.
(Transfers between Faculties or Departments)
Article 32 If a student applies for transfer to another department of his/her faculty, or transfer to another faculty and department or course, the President may permit such transfer after conducting an examination.
2. Regulations concerning transfers between faculties or departments are established separately.
(Study Abroad)
Article 33 The President may permit study abroad of students who wish to study at a foreign university, upon consulting the

Faculty Council.
2. The period of study abroad permitted per the above shall be included in the calculation of the number of years of enrollment. (Prohibition of Dual Enrollment)

Article 34 Students of the University shall not be enrolled in multiple faculties/departments or other universities; provided, however, that this shall not apply to those who participate in the Double Degree Program or the Joint Degree Program offered between the University and its partner universities.

Section 2 Leave of Absence, Withdrawal, Transfer to Another University, and Dismissal (Leave of Absence)
Article 35 When students who are not able to continue their studies for a consecutive period of at least three (3) months apply for a leave of absence, the President may permit such leave of absence upon consulting the Faculty Council.
2. A leave of absence shall be allowed for two consecutive semesters at a maximum; provided, however, that where there are special circumstances, the President may permit a leave of absence for a period longer than two semesters upon consulting the Faculty Council.
3. The total duration of leaves of absence must not exceed eight (8) semesters.
4. If a student who took a leave of absence at his/her request applies for return to study when the period of leave of absence expires or the reason for the leave of absence has ceased during the period of the leave of absence, the President may permit it upon consulting the Faculty Council.
(Withdrawal)
Article 36 When a student applies for withdrawal from the University by clarifying the reason, the President may permit it upon consulting the Faculty Council.
2. If a student who withdrew from the University at his/her request applies for re-entry, the President may permit it upon consulting the Faculty Council.
(Transfer to Another University)
Article 37 When a student applies for transfer to another university, the President may permit it upon consulting the Faculty Council.
(Dismissal)
Article 38 Persons who fall under any of the items below shall be dismissed in accordance with the specified procedure.
(1) Persons who fail to pay tuition and other academic fees by the designated deadlines
(2) Persons whose duration of enrollment has exceeded the maximum years of enrollment specified in Article 20
(3) Persons whose duration of a leave of absence has exceeded the period of leave of absence specified in Paragraph 3, Article 35
(4) New students who have not completed course registration by the designated deadline or who are considered to have no intention to study at the University
(5) Person who was issued with "College student" status or any other type of visa that permits him/her study at the University, however, who has been refused or not granted the visa status, as specified in the Immigration Control and Refugee Recognition Act(Cabinet Order No. 319 of April 4, 1951).
2. Students shall lose their student status upon being dismissed.
3. If a person who was dismissed in accordance with the provision of Paragraph 1 (except for those who fall under item 2 or 3 ) applies for re-entry, the President may permit it upon consulting the Faculty Council.

Chapter 5 Curricula and the Method of Registration
(Curricula)
Article 39 The University offers courses necessary to achieve the objective of the University and the educational objectives
of each Faculty and Department or Course, and formulates systematic curricula.
2. In formulating a curriculum, proper consideration shall be made so that the curriculum will provide academic expertise related to the relevant Faculty and Department or Course, while helping students develop broad and deep knowledge and comprehensive judgment ability, and will foster rich humanity.
3. A curriculum is comprised of required courses, elective courses, and courses that do not count toward graduation, which are assigned to each academic year.
4. The categories of courses, names of the courses, number of credits, and the method of credit allocation and registration for each Faculty, Department or Course shall be specified by the Faculty in its Faculty Regulations.
5. For international students (including returnee Japanese students), special courses may be offered instead of or in addition to some of the courses specified above.
(Method of Classes)
Article 39-2 Classes are conducted using any one or a combination of lectures, seminars, experiments, practical training, or skills practices.
2. As prescribed by the Minister of Education, Culture, Sports, Science and Technology, the University may have students take the classes in the preceding paragraph at places other than the classrooms where the classes are conducted, through the highlevel use of a variety of media.
3. The number of credits earned through the method of classes above shall not exceed 60.
(Term of Classes)
Article 39-3 The term of classes shall be a period of 15 weeks for each semester, or a period of 16 weeks which is divided into two 8-week terms.
2. The President determines the terms of classes upon consulting the Faculty Council.
3. Notwithstanding the above provision, where necessary for education and where sufficient educational effect is expected, classes may be conducted on days other than the specified terms of classes upon deliberation by the Faculty Council.
(Clarification of Grading Criteria, etc.)
Article 39-4 The University clarifies to students the methods and contents of classes and the plan of classes for a year in advance.
2. In evaluating the academic achievements and approving graduation, in order to ensure objectivity and strictness, the University clarifies the criteria thereof to students in advance and appropriately performs such evaluation and approval following the said criteria.
(Granting of Credits)
Article 40 Credits for a course are given to students registered for the course who have attended the classes of the course and passed the examination.
(Calculation of Credits)
Article 41 A credit requires 45 hours of study as a standard, and the number of credits shall be calculated as follows:
(1) For lectures and seminars, a credit equals 15 hours to 30 hours of classes.
(2) For experiments, practical training, and skills practices, a credit equals 30 hours to 45 hours of classes.
(3) For courses offered by means of a combination of two or more forms of lecture, seminar, experiment, practical training, and skills practice, the hours of classes required for a credit shall be determined according to the combination, taking into consideration the standards provided in the two preceding items.
2. Notwithstanding the above provision, the number of credits for a thesis, graduation research, etc., may be determined taking into consideration the necessary academic achievements, etc., when it is deemed appropriate to grant credits based on the evaluation of academic achievements thereof.
3. The hours of classes as the basis of credit calculation shall be determined by the President upon consulting the Faculty Council.
(Procedure for Course Registration)
Article 42 Registration of courses must be completed within the specified period of each semester and receive approval.
2. The provision of the previous paragraph applies to registration of courses of other Faculties and Departments or Courses.
3. With regard to the number of credits that a student must acquire as the requirement for graduation, each Faculty specifies in its Faculty Regulations the maximum number of credits that a student can be registered for in a year or a semester.

## (Registration of Courses of Other Universities)

Article 43 When deemed beneficial for education, the University may allow students to take courses of a university with which the University has an agreement.
2. For the credits of the courses taken in accordance with the above provision, the President may approve a maximum of 60 credits as part of the credits required for graduation upon consulting the Faculty Council.
(Studies at Educational Institutions, etc. Other than Universities)
Article 43-2 When deemed beneficial for education, studies by students in the major course of a junior college or a college of technology, or other studies separately specified by the Minister of Education, Culture, Sports, Science and Technology, may be considered as studies in courses at the University and the credits thereof may be granted.
2. The total number of credits granted under the preceding paragraph and credits granted as acquired at the University under the previous Article shall not exceed 60.
(Transfer of Credits Acquired Prior to Admission)
Article 43-3 When deemed beneficial for education, credits acquired by students for courses taken at a university or junior college (including credits acquired as a non-matriculated student) before admission to the University may be considered as credits acquired through courses taken at the University after admission to the University.
2. When deemed beneficial for education, studies by students as prescribed in Paragraph 1 of the previous Article before admission to the University may be considered as studies of courses at the University and the credits thereof may be granted.
3. Except for cases of mid-course entry or transfer to another university, etc., the total number of credits acquired or granted under the preceding two paragraphs and the credits deemed to have been acquired at the University under Paragraph 2 of Article 43 and Paragraph 2 of Article 43-2 shall not exceed 60.
(Application Mutatis Mutandis of Provisions to Study Abroad)
Article 44 The provision of Paragraph 2, Article 43 shall apply mutatis mutandis to cases of students who study at a university abroad.
(Educational Personnel Licenses and Other Qualifications)
Article 45 The types of educational personnel licenses and other qualifications that can be acquired in each
Faculty/Department or Course are specified by the Faculty in its Faculty Regulations.
2. The courses and the number of credits necessary to acquire the above qualifications shall be specified by the Faculty in its Faculty Regulations.

Chapter 6 Exams and Grades
(Exams)
Article 46 An exam shall be either a written or oral exam; provided, however, where deemed necessary, submission of a thesis or other means may replace the exam.
2. The maximum exam score is 100 points, and 60 or above shall be considered passing.
(Term of Exams)
(Article 47) Exams are conducted at the end of each semester or academic year, provided, however, where deemed
necessary, exams may be conducted at other times.
(Conditions for Taking Exams)
Article 48 Students are not allowed to take exams of courses other than those they have registered for.
2. Students who do not pay tuition, etc. are not allowed to take exams.
3. Students are not allowed to take exams during the period of a leave of absence or suspension.
(Makeup Exams)
Article 49 Students who are unable to take the exams specified in Article 47 due to illness or other unavoidable circumstances may take makeup exams.
2. Students who intend to take a makeup exam must submit an application therefor.
(Indication of Grades)
Article 50 Results of exams are graded S ( 100 to 90 points), A ( 89 to 80 points), B ( 79 to 70 points), C ( 69 to 60 points), D (59 to 40 points), or E ( 39 points and below). S, A, B, and C are passing grades and D and E are failing grades.
(Notification of Grades)
Article 51 Results of exams are notified to students.
Chapter 7 Graduation and Bachelor's Degrees
(Credits Necessary for Graduation)
Article 52 The credits necessary for graduation in each Faculty/Department or Course are specified by the Faculty in its Faculty Regulations.
(Requirements for Graduation)
Article 53 The requirements for graduation are as follows:
(1) Having been enrolled in the University for at least four (4) years
(2) Satisfying the requirements for graduation specified by the student's Faculty
2. Notwithstanding the above provision, graduation of students who have been enrolled in the University for at least three (3) years and are regarded as having acquired the credits required for graduation with excellent grades may be approved pursuant to the rules specified by the Minister of Education, Culture, Sports, Science and Technology.
Article 54 Deleted
(Bachelor's Degrees)
Article 55 One of the Bachelor's degrees listed below will be granted to graduating students according to the courses they have taken, along with the diploma issued.
(1) Faculty of Letters Daytime Course (except Department of Education) and Evening Course (except Department of Education) Bachelor of Arts
(2) Faculty of Letters Daytime Course Department of Education and Evening Course Department of Education Bachelor of Education
(3) Faculty of Economics Daytime Course and Evening Course Bachelor of Economics
(4) Faculty of Business Administration Daytime Course and Evening Course Bachelor of Business Administration
(5) Faculty of Law Daytime Course and Evening Course Bachelor of Law
(6) Faculty of Sociology Daytime Course and Evening Course Bachelor of Sociology
(7) Faculty of Science and Engineering
a. Department of Mechanical Engineering Bachelor of Science and Engineering
b. Department of Electrical, Electronic and Communications Engineering Bachelor of Science and Engineering
c. Department of Applied Chemistry Bachelor of Science and Engineering
d. Department of Civil and Environmental Engineering Bachelor of Engineering
e. Department of Architecture Bachelor of Engineering
(8) Faculty of Global and Regional Studies
a. Department of Global Innovation Studies Bachelor of Global Innovation Studies
b. Department of Regional Development Studies Bachelor of Regional Development Studies
(9) Faculty of International Tourism Management Bachelor of International Tourism Management
(10) Faculty of Life Sciences Bachelor of Life Sciences
(11) Faculty of Information Sciences and Arts Bachelor of Information Sciences and Arts
(12) Faculty of Food and Nutritional Sciences
a. Department of Food and Life Sciences Bachelor of Food and Life Sciences
b. Department of Data Science for Food Systems Bachelor of Data Science for Food Systems
c. Department of Nutrition and Health Sciences Bachelor of Nutrition and Health Sciences
(13) Faculty of Information Networking for Innovation and Design Bachelor of Information Networking for Innovation and Design

b. Department of Child Studies Bachelor of Child Studies

Chapter 8 Rewards, Punishments, and Scholarships
(Awards)
Article 56 The President may award persons with excellent personality or academic performance, persons who have taken remarkably good actions, and persons who have made remarkable achievements in extracurricular activities.
2. The types of awards are as follows:
(1) Scholarships: Exemption from or reduction of academic fees for a specific period
(2) Honors: An honorary certificate and prize
(3) Other awards
(Disciplinary Measures)
Article 57 The President may take disciplinary measures of reprimand, suspension, or dismissal against students who have violated the Academic Rules and Regulations or other regulations of the University, or taken any action contrary to the role of a student, upon consulting the Faculty Council and considering the degree of seriousness of the action and educational significance.
2. Students shall not be dismissed unless they are:
(1) those who behave badly with no prospect for improvement;
(2) those who fail to engage in academic work with no prospect for achievement;
(3) those who do not regularly attend classes without due reason; or
(4) those who disrupt the order of the University or take any other action contrary to the role of a student.
(Scholarships)
Article 57-2 The University offers scholarships.
2. Regulations concerning scholarships are established separately.

Chapter 9 Itaku Students, Non-matriculated Students, and Special Auditing Students

## (Itaku Students)

Article 58 The University may permit students assigned from the national government, a corporation, or other organization (hereinafter, "Itaku Students") to study at the University.
2. Those who are permitted to study at the University as Itaku students must have university entrance qualifications.
3. Regulations concerning Itaku students are established separately.
(Non-matriculated Students)
Article 59 When requested by a person intending to take a specific course, the University may permit the person as a nonmatriculated student to take the said course.
2. Regulations concerning non-matriculated students are established separately.
(Special Auditing Students)
Article 60 When requested by a student of another university (including universities abroad) or junior college (hereinafter, "universities, etc.") to take courses at the University, the University may admit said student as a special auditing student upon consultation with the relevant university, etc.
2. Regulations concerning special auditing students are established separately.
(Application Mutatis Mutandis of the Academic Rules and Regulations to Itaku Students and Non-matriculated Students)
Article 61 Except when otherwise specified, these Academic Rules and Regulations shall apply mutatis mutandis to Itaku students and non-matriculated students. In such case, the term "students" in the Academic Rules and Regulations shall be replaced with "Itaku students" or "non-matriculated students" where necessary depending on the context.

Chapter 10 International Students
(International Students)
Article 62 Regulations concerning international students are established separately.
(Application Mutatis Mutandis of the Academic Rules and Regulations to International Students)
Article 62-2 Except when otherwise specified, these Academic Rules and Regulations shall apply mutatis mutandis to international students. In such case, the term "students" in the Academic Rules and Regulations shall be replaced with "international students" where necessary.

Chapter 11 Tuition, etc.
Section 1 Application Fees and Screening Fees
(Application Fees)
Article 63 Applicants for admission must pay the application fees specified in Appendix 1.
2. Applicants for transfer between Faculties or Departments must pay the application fee specified in Appendix 2.
(Screening Fees)
Article 64 Applicants wishing to become non-matriculated students must pay the screening fees specified in Appendix 4.
Section 2 Academic Fees, Non-matriculated Enrollment Fees, etc.)
(Tuition, Admission Fee, and Other Academic Fees)
Article 65 Academic fees for students are comprised of the admission fee, tuition, facility fee, lab fee, and equipment fee, and the specific amount of each fee is as shown in Appendix 3.

## (Reduction of Academic Fees)

Article 66 The President may exempt students who are excellent in academic performance or personality from payment of a part or all of their academic fees upon consulting the Faculty Council.

## (Academic Fees for Withdrawn Students)

Article 67 The University collects from students who have withdrawn or have been ordered to withdraw the tuition, facility fee, lab fee, and equipment fee for the relevant semester. The same shall apply to students who have been suspended.
(Academic Fees for Students on a Leave of Absence)
Article 68 The University collects from students who are on a leave of absence a half of the facility fee for the period of the leave of absence and does not collect the tuition, lab fee, or equipment fee.
(Academic Fees for Itaku Students and Non-matriculated Students)
Article 69 Tuition and other academic fees for Itaku students, and tuition and other academic fees as well as the registration fee for non-matriculated students, are as shown in Appendix 4.

Section 3 Processing Fees
(Processing Fees)
Article 70 The types and amounts of processing fees are specified separately.
Section 4 Restriction on Refunding of Academic Fees
(Restriction on Refunding of Academic Fees)
Article 71 Paid academic fees will not be refunded in principal.
Chapter 12 Irregular Programs

## (Extension Programs)

Article 72 The University may set up extension programs targeting people outside the University with the aim of promoting dissemination of academic cultures.

## (Extracurricular Programs)

Article 73 The University may set up extracurricular programs besides regular programs as necessary, in order to help students acquire special knowledge and skills.
(Regulations Concerning Irregular Programs)
Article 74 Regulations concerning the programs specified in the preceding two Articles are established separately.
Chapter 13 Welfare Dormitories, Student Dormitories, and Welfare and Health Facilities
(Welfare Dormitories)
Article 75 The University has welfare dormitories, such as seminar houses.
(Student Dormitories)
Article 76 The University has student dormitories, such as training houses.
2. The purpose of student dormitories is to train students to live a social and disciplined life through living in a group.
(Health Center)
Article 77 The University has a Health Center to provide treatment related to health and hygiene for the faculty and administrative staff members and students of the University.

## (Gyms and Athletic Fields)

Article 78 The University has gyms and athletic fields, to support physical development.
Article 79 Deleted
Chapter 14 Auxiliary Rules
Article 80 Deleted
Article 81 Deleted
(Revision)
Article 82 Revision of these Academic Rules and Regulations shall be proposed to the Board of Trustees by the President upon consulting the Faculty Council of each Faculty, and finalized by the Chairman after discussions with the Board of Trustees.

Supplementary Provisions
